PC Vale and his colleagues are keen to see that the Neighbourhood Watch Scheme is re-introduced in the village and the Parish Council support this, but of course it needs people to volunteer to become involved!

Thanks to everyone who helped make this year's bonfire a great success. Between us, the Parish Councils of Linby & Papplewick, together with the Enterprise Group worked hard to provide the best ever display, sold out of more food, had a good bonfire, the fire brigade attended and managed to stay all evening this year. The children seem to like the blue lights and sirens! Even the weather was good again!

A total of £1400 has been put into the playing field fund from the evening and we have received several favourable comments about the event, particularly about the good value we give. This of course would not be achievable without the tremendous generosity of our sponsors, who all have local connections either by living in the villages or having business interests locally.

Parish Councillor Vacancies.

Could you be a councillor? It is of course is the bottom rung of democracy in this country. Parish Councils are increasingly being consulted on all manner of things and this trend will continue as the Government recognises the importance of local government. It remains to be seen what will happen in future reorganisations, there is talk of Nottinghamshire becoming a Unitary Authority and some tiers of District & Borough councils disappearing altogether, with more powers being devolved to Parish level.

The next term for serving as a councillor will start in May 2007, when local elections are held. There will be vacancies on Papplewick Council next year as several existing councillors are giving up their positions. Parish Councillors normally serve a four-year term, or several four-year terms in a lot of cases! Training courses on a wide range of related subjects are available.

The Village Hall management committee are delighted to learn that following the winning of the Gedling area heats of the Best Run Village Hall; they went on to come second in the whole of Nottinghamshire County competition. Congratulations to Dunham in north Notts, who won! Particularly pleasing when it is realised that there are over 800 eligible village & community halls in the county, but fortunately not all of them entered the competition!

Some of the prize money (a total of £600) will be spent on an additional camera for the CCTV system, which has already proved it's worth in keeping potential problems under control.

At it's last meeting Papplewick Parish Council agreed the Annual Budget following a meeting of the Finance Committee. The annual precepts will this year be very close to last year's figure, the provisional budget being £9833.

Amongst other items the question of making donations to various bodies was discussed and, similar to previous years the following was agreed.

- £50 to Papplewick Pumping Station, nationally one of the best examples of its type.
- £50 to Papplewick Cricket Club, who provide training facilities for local youngsters.
- £50 to Papplewick & Linby Day Centre, who provide a meeting place for senior citizens.
- £100 to the Parochial Church Council towards the upkeep of St James' churchyard.

It was also agreed to authorise the purchase of equipment to put on the skateboard park, now that the concrete slab has been completed. There are also further maintenance works to be carried out on the existing equipment. Two picnic benches have also been ordered for the field.

MOOR POND WOOD



It was mentioned in the last newsletter about the prospect of a new roundabout being provided at the junction of Moor Road & Papplewick Lane. This was to be either full sized or alternatively a mini roundabout depending on surveys being carried out by Notts County Council & the developers, Coftons. Unfortunately information about the progress of these works has been very limited and no updated information has been received. The council is contacting Coftons for a progress report on the scheme.

Concerns were raised regarding the proposal to use some of the land in Grange Cottages wood to install a roundabout, particularly after so much good work has been carried out to restore this area. The Parish Council and Friends of Moor Pond Wood are actively pursuing information about the suggestion and Paddy Tipping MP is also involved.

In Papplewick Dam woods tree felling operations have taken place. The most obvious sign of this is the removal of most of the large "Crack Willow" tree adjacent to the entrance to the wood by the notice boards. It had been identified as dangerous due to most of it being dead.

Negotiations are taking place with a view to establishing a footpath through from the woods to the meadow by the church; this would then form part of a circular route. Eventually a new bridge will be built across the river fairly close to the weir. The route people tend to take at present through the field is not a right of way and should not be used.

Nottinghamshire County Council archaeology department will be carrying out survey work across the whole site with a view to producing a digital map of the site. Certainly the example shown of a similar map at the last Friends meeting was very impressive.

There is to be "work day" on Sunday December 17th for clearing undergrowth and general maintenance work. Meet at 10.30 am at the Moor Road entrance, by the notice boards.

On the same day it is proposed to undertake some archaeological digging in Grange Cottages Wood in the quest to find the missing "plug hole", which was known to exist. We will be working from information supplied by the diviners at a recent meeting, so it will be interesting to see what we unearth and discover.

Traffic concerns in the village.

At the last council meeting a delegation of residents, predominately from Main Street, attended the Public Forum part of the meeting to raise their concerns about both the quantity of traffic passing through the village and the speed of some drivers. A survey of traffic flow towards and away from the crossroads had been undertaken which showed high levels at certain times of day. The council is awaiting confirmation of these results to compare with similar information from Notts County Council before issuing a press statement at a later date.

It is known however, that there is considerably more through traffic than when a survey was last undertaken several years ago. The speed of traffic also appears to have increased. The position would appear to only be getting worse, with the proposed housing on Papplewick Lane and the Wigwam site. In fact all new development within the Hucknall area will inevitably produce more potential for increased traffic. The prospect of 2000 new jobs on Rolls Royce site, whilst welcome from an employment point of view will additionally create more traffic.

It is not known yet if the new speed limit reminder signs on Mansfield Road (50 mph) have had any effect; presumably this has been re-signed on road safety grounds and covers the whole length from Redhill roundabout to Mansfield.
